The recorded version of the concert will be aired on April 2 on fonclaire.com

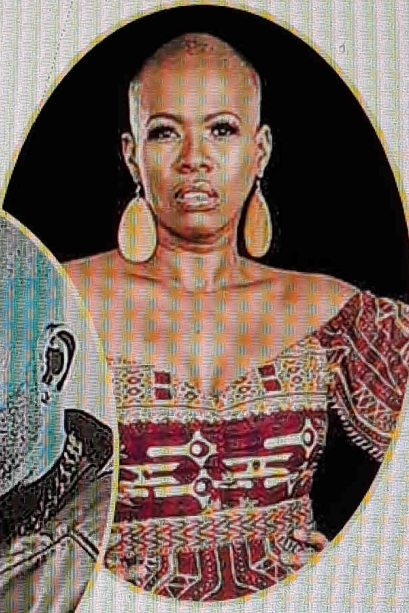
